Choose the Right Audit Level

Each audit level builds on the last—from fast screening to investment-grade decision support.

Environ structures energy audits around the three-level ASHRAE framework — scope, rigor, and deliverables to match the client's decision needs. Level 2 includes Level 1 requirements, and Level 3 builds on both. That means clients can start with a practical screen or move directly to deeper analysis when a major project or capital request is on the table.

Primary Deliverable	High-level findings and practical next-step recommendations	Prioritized investment roadmap with more detailed savings, cost, and payback analysis	Decision-grade analysis to support design, capital planning, and project approval
